

## **GOLDEN ROAD BEERLAND DREAM BAR SWEEPSTAKES - OFFICIAL RULES**

1. NO PURCHASE NECESSARY.

2. The “Golden Road Beerland Dream Bar Sweepstakes” (“Sweepstakes”) is open to residents of the United States who are 21 years of age or older. Void where prohibited.

3. Sweepstakes begins at 12:00:00 a.m. Central Daylight Time (“CDT”) on May 18, 2018 and ends at 11:59:59 p.m. CDT on August 31, 2018 (“Sweepstakes Period”). The Sweepstakes Period is divided into three (3) Entry Periods (each an “Entry Period”) as defined in the chart below:

Two (2) Ways to Enter: (a) Internet: Visit <http://goldenroad.la/beerlandsweeps> (“Website”) during the Sweepstakes Period and follow the online instructions to complete and submit an online entry. (b) Text Message: Use your SMS-enabled mobile phone to text “BEERLAND” to shortcode 78896. Participants must have a mobile phone with text messaging capabilities to enter by text message. Participants entering this Sweepstakes via text message may incur a standard text message charge from their wireless service provider for each message sent and received. Check with your wireless service provider for details on these and other applicable charges. You may receive reply messages. Participants are solely responsible for any such wireless charges. In the event of a dispute regarding the identity of an online entrant, the authorized subscriber of the email account used to enter will be deemed to be the entrant, and must comply with these rules. The authorized account subscriber is the natural person who is assigned the email address by the ISP or other organization responsible for assigning email addresses. 6. Winners will be selected in a random drawing to be held on or about each Drawing Date as defined in Rule #3 from among all eligible entries received during the corresponding Entry Period. Non-winning entries will carry forward to subsequent drawings. All drawings will be conducted by an independent judging agency, whose decisions are final in all matters relating to this Sweepstakes. See Rule #10 for Prize details. Winners may not substitute or transfer prize, but Sponsor reserves the right to substitute prize with a prize of equal or greater value. Limit one (1) Grand Prize or one (1) First Prize per person.

7. Grand Prize and First Prize: All Grand prizes will be awarded. The First Prize will be awarded. Odds of winning depend on the number of eligible entries received per Entry Period. The potential winners will be notified by phone, text or email and will be required to respond to the notification within forty-eight (48) hours indicating whether he/she can accept the prize. If no response is received within the time allotted, an alternate potential winner will be randomly selected. Any alternate potential winners selected will also be required to respond to the notification within forty-eight (48) hours. Sponsor is not responsible for suspended or discontinued Internet, wireless, or land-line phone service which may result in a potential winner not receiving initial prize notification. Potential winners will be required to complete, sign, and return an affidavit of eligibility and liability and publicity release via email, fax or overnight mail within seven (7) days of prize acceptance.
